The principal purposes and functions of the Administration, in accordance with the Agreement signed November 9, 1943, by the United Nations and Associated Nations, are:

"To plan, coordinate, administer or arrange for the administration of measures for the relief of victims of war in any area under the control of any of the United Nations through the provision of food, fuel, clothing, shelter and other basic necessities, medical and other essential services; and to facilitate in such areas, so far as necessary to the adequate provision of relief, the production and transportation of these articles and the furnishing of these services."

The travel on which the bearer is engaged is necessary in the performance of his or her duties as a representative of the Administration.

This document is issued under the authority of Resolution No. 36 of the First Session of the council of said Administration, which provides:

"Whereas

"The Council has in mind the importance of securing the expeditious and unhindered travel of officials and employees of the Administration to permit the prompt fulfillment by the Administration of the urgent tasks entrusted to it; it is therefore

"Resolved


"That the Council recommends:

"That the Director General issue to the officials and employees of the Administration for use when travelling on official business, a document identifying the official or em-

ployee and requesting, in the name of the Administration, that all appropriate facilities be granted the bearer.

"That all member governments give full recognition to such documents and instruct their diplomatic, consular, customs, and immigration services, and any other services which may be concerned, to recognize such documents as entitling the bearer to all appropriate facilities."

The present certificate has been delivered for presentation to the appropriate High Authorities in order that the bearer may obtain such facilities, privileges, and immunities as may be accorded by virtue of his or her aforementioned position.

PRIVATE CONTRACT OF LEASE

In Athens, this twentieth(20th) day of November 1947, between Mr. Nicolas Zorbas, Advocate, named hereafter "Lessor" and Mr. Daniel E. Wright, Engineer, named hereafter "Lessee", it has been agreed as follows:

The Lessor, being owner of a house at Psychico, Diamandidis Str; No 19, does hereby lease the upper floor of his house with furnitures, to be used by the Lessee for residence for him and his wife under the following conditions:

1o) This lease is to begin from first(1st) December 1947 and to terminate on the(30th)thirtieth November 1948.-

2o) The rent has been stipulated To the equivalent in Drachmas at the day of the payment of Hundred and twenty Golden S Sterling Pounds(G.S.P.120-/-) annually, which will be paid as follows: a)At the signature of the present the equivalent in drachmas of thirty Golden Sterling Pounds (G.S.P. 30-/-)will be deposited as guarantee. This guarantee will represent the rent of the last three months before the termination of the lease, whenever this will take place. b)The equivalent in Drachmas of other thirty Golden Sterling Pounds (G.S.P. 30-/-) for the rent of the first three months of the lease. c)The first day of every new period of three months the equivalent in Drachmas of Thirty Golden Sterlins Pounds (G.S.P.30-/-) will be paid for rent of the same period. Those partial payments of rents, at the beginning of every new period of three months, as above will continue during all the stipulated period of the lease, even in case of renovation, save the case of the rent of the last three months before the termination of the lease, which rent will be compensated with the aforesaid guarantee.-

3o) The Lessee must make good and proper use of the premises and return it, at the termination of the lease, in good condition. He

will be liable for any damages, except those of the usual wear.-

40) The Lessee is responsible for the payment of the light and water bills and the salary of the gardener.-One third (1/3) of those expenses will be at the charge of the Lessor.-

50) The furnitures and utensils delivered to the Lessee are those mentenned in the list signed by both parties. The Lessee must return them in good condition, at the termination of the lease and he is responsible for the payment of any damage, except those of usual wear.-

- 60) The Lessee during this period of the lease or in case of renovation of the lease also, may, after the previous approval and consent of the Lessor, sublease the premises for the remainder of the period of lease, until its termination.-

Wherefor the present contract has been signed in duplicate by both parties, one for the use of each of them.-

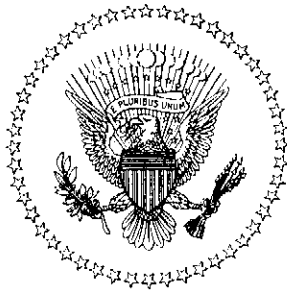
